JPMorgan Core Bond Fund Class R6

Ticker: JCBUX

Gross expense ratio: 0.35% as of 07/01/2024

Objective: The investment seeks to maximize total return by investing primarily in a diversified portfolio of intermediate- and long-term debt securities.
